- Deadline for submission will be on September 3, 2021 at 11:00 am and thereafter public bid opening will take place at 11:30 am in the District board room in the presence of the bidders or their representatives who will wish to attend.
- Late bids shall be rejected, and Kiruhura District Local Government reserves the right to accept or reject any bid.
